## Hollywood Distributor Fantastic Films International will exclusively distribute Dygra Films' feature films worldwide

- *THE OPERATION OPENS UP THE NORTH AMERICAN MARKET FOR DYGRA FILMS*

**LA Coruña, 20 April 2007** The animation production company **Dygra Films** has just inked a strategic agreement with the Hollywood distributor / producer **Fantastic Films International** for the worldwide release(\*) of **Dygra's** third animated feature film, ***Spirit of the Forest***, within the framework of a global approach to advance in expansion plans and international presence of their feature films.

The goal of this agreement is to be able to access the major partners in each country, achieve a joint release to gain the maximum return of the international release and, above all, enter into the North American market, the most important and competitive worldwide. In fact, the North American version of ***Spirit of the Forest*** is already in progress, which will count on a first class cast to dub the main characters.

The president of **Dygra Films**, Manolo Gómez, states "this agreement is a great jump for the internationalization of our productions and ratifies the interest that these cause in the rest of the world. I am very excited with this new collaboration stage with **Fantastic Films International**, which will allow us to approach international sales globally, and above all, it will give us access to such a difficult market as the North American market".

**Fantastic Films International** is committed, as their president Roxane Barbat says, "to representing feature films with a unique combination of great writing and flawless production, which create universal stories that will stand the test of time. We are delighted to have entered into this relationship with such a uniquely talented animation house as DYGRA. Mr. Manolo Gomez's artistic sensibilities are a perfect match for our company".

**Fantastic Films International** enjoys a rapidly expanding worldwide distribution network and attends all the major film markets, such as the Cannes International Film Festival, where this year they will introduce ***Spirit of the Forest*** alongside ***AGENT CRUSH***, currently in post production in the UK.

**Editorial note.-** *Dygra, of the production company Dygra Films, is the only 3D animation studio in Europe that carries out all the production process of a feature film and whose efforts in R&D have allowed the creation of an own work model. All this made them deserve in 2002 a nomination for the Príncipe Felipe Award for Business Excellence in the Technological Innovation category. Their first two feature films, "The Living Forest" (2001) and "Midsummer Dream" (2005) have become international successes and have given three Goya Awards to Dygra Films. At the moment the production company is developing, among other projects, two animated feature films, "Spirit of the Forest" and "Holy Night!"*
